V. Public Participation

A. SDC report from John Ghilarducci from FCS Group. Report and discussion resulted in agreement to schedule public hearing on proposed restructuring of SDCs for June 22nd, and notice submitted for publication in Newberg Graphic March 29th edition in order to comply with 90 days' notice requirement.

During discussion, directors and Red Crawford challenged population numbers for Newberg and Dundee in Ghilarducci's report; he agreed to examine and revise these; Peter Siderius requested to see numbers since 2002.

B. Others not on agenda – Ted Crawford asked why the last Yamhill County Trails Collective meeting had been cancelled. Don Clements answered that the core meeting members had concluded there was not enough to move forward with at the time of the meeting. Crawford asked about the property that Chehalem Paddle Launch is located on, a parcel owned by Tom Edwards. Crawford said he supports CPRD trying to purchase or swap for the property, or to get Oregon State Parks Department to purchase it. Discussion ensued with Bart Rierson on potential alternative sites to located the launch on. Bart reported that he went to a meeting with Jim McMaster with Yamhill County Parks in order to ask to locate the launch at Rogers Landing; the response was that this was not deemed available option. Clements said he would bring to the next Board meeting, a timeline for DEQ to close the landfill located there. Mike Ragsdale said he wants CPRD to make an aggressive effort, through the CPRD attorney, to secure access to the Edwards property. Clements said he would contact attorney John Bridges tomorrow, and at the least, propose an agreement for CPRD to assume all liability.
