Objective: to create a mural for the fitness facility. The goal of the project was to display the branding of KLX with outdoor athletic scenes for their office headquarters in Westlake Village, California. Of 400 schools invited to apply, my submission was chosen as the winning design. They later invited me back to paint two more murals at their corporate headquarters.
