**A RESOLUTION IN RECOGNITION AND APPRECIATION OF THE

**WHEREAS**, the Chehalem Park and Recreation District (CPRD) formed the Pickleball Citizens Advisory Committee to provide guidance, support and community insight for the development, planning and promotion of pickleball within the District;

**WHEREAS**, the collective efforts of the CPRD Pickleball Citizens Advisory Committee created meaningful opportunities for multigenerational players to gather; and

**WHEREAS**, the 2024–2026 Pickleball Citizens Advisory Committee members were Nick Konen, Sheryl Greiner, Bob Oleson, Linda Sandberg, Lance Trantham, and Laurie Rauch;

**WHEREAS**, the 2021–2024 and 2024-2026 Pickleball Citizens Advisory Committee conducted regular meetings and provided recommendations, as reflected in publicly available agendas, minutes and other materials.

**WHEREAS**, throughout its tenure, the Pickleball Citizens Advisory Committee contributed significantly to community engagement; planning of future pickleball facilities; discussions on design, amenities and maintenance and assisted CPRD staff in gathering community feedback and shaping strategies for sustained pickleball development; and

**WHEREAS**, the District completed the primary objectives for which the Pickleball Citizens Advisory Committee was established, and ongoing pickleball planning, operations and

community engagement can now be effectively managed by CPRD staff and standard District public involvement processes;


