#### V. Public Participation

A. Survey – Ben Patinkin presented the results of the opinion poll. Discussion followed. On Don Loving's recommendation, the Board decided to meet July 24<sup>th</sup>

in order to continue discussion and make a decision on whether to go out for a bond measure for the November election then.

B. Pool Committee Report – This item did not stand alone, as Jim Seymour and Mike Shrage participated in the discussion above, in item A.

C. Veritas Proposed Use and Easement Agreement – Mike Ragsdale recommended the Board move on, because (Mike Stice) Veritas representative had worked with Superintendent Don Clements on contract changes, including 99-year term, and knew Veritas needed to be present if they wished to move forward and were not present.

D. Others not on agenda – David Ulbricht agreed to return, if his scheduled allows, for the July meeting to continue discussion then. Discussion included Board request for figures on how much the tax rate would increase and how much revenue a bond measure would generate for bond projects from three categories – One, pool renovation only; two, pool and fitness center renovation; three, all other potential bond projects included. Ulbricht estimated that 50 cents per 1,000 would amount to \$16 million to spend on bond projects.
